- 1. The Republic of Croatia has received a Loan from the International Bank for Reconstruction and Development (The World Bank) toward the cost of the Justice Sector Support Project (JSSP), and it intends to apply part of the proceeds toward payments under the contract no. JSSP-CW-4 "Reconstruction of the building of former military base "Istarskih brigada" for the needs of County SAO Pula, Municipal SAO Pula and land registry department of the Municipal Court in Pula"
- 2. The JSSP Project Implementation Unit (JSSP PIU), on behalf of the Ministry of Justice now invites sealed bids from eligible bidders for Contract No. CW-4 involving reconstruction of the building of former military base "Istarskih brigada, located in Rovinjska street 2a in Pula.

#### 3. Short description of the location, size and structure of the building:

The object of the reconstruction is the building of former military base "Istarskih brigada" for the needs of County SAO Pula, Municipal SAO Pula and land registry department of the Municipal Court in Pula, Rovinjska st. 2a, Pula cadastre particle no. 978/2, Pula.

In accordance with the terms of reference the design studio Capital - Ing from Zagreb has prepared all technical documentation for reconstruction of the existing building and construction of smaller, necessary annexes in the courtyard part, based on which the location permit and approval of main project have been obtained.

Based on the TOR the existing dimensions of the building will remain unchanged, except necessary smaller additions needed for the new organization.

In order to ensure better access to the building installation of the elevator is envisaged. Vechicle access to building is located on NW part of the plot, from Rovinjska street.

Existing building consists of two levels – ground floor and the 1st floor. Height of the building measured from the surrounding terrain to bottom of the roof is 7,80 m, and 11,76 m to top of the roof.

Reconstruction includes complete sanation of the constructive parts, new water and sewage installations, new electrical installations of low and high current, installation of heating system, AC system, hot water system, ventilation, gas installation, fire-alarm installation, new joinery, metal works and facade.

Total nett squre area of the building is 2093,90 m2.

Expected completion date is 11 months of commencement of works.

- 4. Bidding will be conducted through the *national competitive bidding (NCB)* procedures as specified in the World Bank's <u>Guidelines: Procurement under IBRD Loans and IDA Credits</u>, (current edition), and is open to all eligible bidders as defined in the guidelines.
