Activity 2.1.2 BIS

Conducting a study visit to learn about treatment and training programmes in other MS

Study visit to Madrid, Spain was conducted from 28 May to 2 June 2017. Five representatives of the Probation Sector visited the General Secretariat of Penitentiary Institutions, CIS (Social "Melchor Rodríguez Insertion Centre García" Alcalá de Henares (Open Regime Prison) and the "Josefina Aldecoa" CIS (Social Insertion Centre) in Navalcarnero, and met their Spanish colleagues. In this way they had direct experience with professionals and offenders regarding treatment programmes and this will help an effective implementation of programmes in the Croatian Probation System.



Activity 2.2.3

Conducting Training of Trainers (ToT) for at least 5 staff members from the Probation Service

The training was conducted by two experts from 5 to 9 June and seven representatives of the Probation Sector finished the training – three representatives from Central Office in the Ministry of Justice and four representatives from probation offices. The participants of the training of trainers gained the skills and knowledge needed to become trainers of future generations of probation officers and to teach them how to treat specific categories of offenders.



The European Union's Transition Facility for Croatia Activity 2.2.4

Conducting trainings for at least 40 staff members from the Probation Service

1st mission of this activity was implemented by three experts from 6 to 10 February. The first training of probation officers designed in the activity 2.2.2 was conducted in this mission. The treatment programme was for gender-based violence offenders under probation and 20 probation officers were trained.



 2^{nd} mission of this activity was implemented by two experts from 6 to 10 March. This was the second training and 15 probation officers were trained, in the area of the treatment programme for sex offenders.



3rd mission of this activity was implemented by three experts from 27 to 31 March and 22 representatives from the Probation Sector finished the training. This time the topic was treatment programme for general offending and general violence. The training followed a practical approach that permitted participants to practice new skills on group therapy.



Activity 3.3.4

Monitoring ES pilot project and preparing monitoring report(s)

1st mission of this activity was implemented by one expert from 30 January to 3 February. The design and general outline of the EM Monitoring and Evaluation Plan was presented to the Central Office.



 2^{na} mission of this activity was implemented by one expert from 25 to 27 April. The electronic monitoring (EM) pilot project began the 17^{th} of February 2017 with the first case in Conditional Release (CR) under EM in Croatia. This activity aimed to organise the midterm evaluation of the EM pilot project after 66 days from the beginning of the EM implementation.

3rd mission of this activity was implemented by two experts from 29 May to 2 June. This activity aimed to organise the final evaluation of the EM pilot project after 100 days from the beginning of the EM implementation.

Performing analysis of results of ES pilot project and preparing analysis report with recommendations for permanent and sustainable introduction of ES system

1st mission of this activity was implemented by one expert from 29 May to 1 June. The purpose of this mission was to start doing some analytic work on the final results of the electronic monitoring pilot project.

2nd mission of this activity was implemented by one expert from 5 to 9 June, for the analysis of results of the Electronic Monitoring EM pilot project after the final evaluation of the pilot. During this mission, all the information collected during the activity 3.3.4 was analysed and drafted in a technical report.



Activity 4.1.2

Preparing PR guidelines with messages to be communicated and methods to be used, including identification of target groups

2nd mission was implemented by two experts from 16 to 20 January. The PR Strategy and the Action plan were finished and the PR materials that were discussed during the previous mission, leaflets and brochures with general information about probation, were designed. The leaflets and brochures were designed in order to promote the visibility of Probation in Croatia.

Probation officers and offenders around Croatia took pictures on this topic and the best 20 pictures were selected by an independent jury. This exhibition was organised in the Zrinjevac square from 24 to 30 April.
